Standard Operating Procedures for Purchase of CBD Hemp Products

Any Buyer that wishes to purchase CBD Hemp Product must follow these Standard Operating Procedures as outlined below:

The Buyer, Seller and Representative will sign a mutual Non-disclosure, Confidentiality and Non-Circumvention agreement. The Seller and Representative will sign a Commission Agreement.

Buyer will provide a SIGNED AND DATED Letter of Intent outlining the information below:

- a. Pricing REQUESTED
- b. Amount of product requested
- c. Type of contract (spot buy or monthly contract)
- d. Quantity details as well as basic structure of transaction

Buyer will provide a proof of funds verification letter from their Attorney and/or the Attorney's contact information. Proof of funds verification will be required prior to Purchase and Escrow Agreement to Buyer.

The following are considered valid proof of funds for purposes of this SOP:

- a. Letter from bank or Escrow Agent on official letterhead signed by Bank Officer or Escrow Agent along with contact details.
- b. Escrow account showing verifiable funds along with Escrow Agent's contact details.

Proof of funds verification will be complete only AFTER the LAWYER or Authorized Agent of the Seller speaks to Buyer's Bank Official, Escrow Agent in charge of funds in escrow, or Buyer's Attorney who is holding funds in an escrow account.

Proof of Product and/or Certificate of Authenticity (COA) from any product being purchased that is "on the ground" will be provided once funds are verified. On orders that are yet to be manufactured, no COA's or Proof of Product will be provided to the Buyer, as these are verifications and test results of another Buyer's product, and the confidentiality of previous transactions shall not be breached.

Seller or its Agent will then issue an Escrow Agreement and Purchase Agreement to the Buyer. Buyer will then execute these agreements and proceed to move funds into the Seller's designated third-party escrow account. This step must be completed before the transaction may move forward. *****Buyer may not use their own Attorney's escrow account to facilitate the transaction beyond this point unless granted this exception upon submission of LOI*****

Following movement of funds to Seller's third-party escrow account, product will be made available at quarantine to Buyer in accordance with the terms of the Purchase Agreement.

Buyer will be provided with opportunity to test product via third-party testing facility prior to taking delivery of product.

Once Buyer has accepted product test results, funds will be released from escrow to pay the Seller and any applicable commissions will be paid to Representative per a separate Agreement.
